SETTLEMENT AGREEMENT

- 1. On or about **4/24/2018** an anonymous complaint was filed with the RI Department of Labor Training, Labor Standards Section alleging a violation of R.I.G.L. § **28-14-19.1** An investigation was conducted by: Dianne Tefft, Labor Standards Investigator;
- 2. As a result of the investigation on 4/24/2018 it has been substantiated that JS Interior Construction Inc has misclassified 27 employees as independent contractors and has failed to pay wages to the employees in violation of R.I General Law §28-14-19.1 Misclassification of Employees. —(a) The misclassification of a worker whether performing work as a natural person, business, corporation, or entity of any kind, as an independent contractor when the worker should be considered and paid as an employee shall be considered a violation of this chapter.
- In addition to any other relief to which any department or an aggrieved party may be entitled for such a violation, the employer shall be liable for a civil penalty in an amount not less than Fifteen Hundred dollars (\$1500) and not greater than Five Thousand (\$3000) dollars for each misclassified employee for a first offense, which shall be shared equally between the department and the aggrieved party. The parties agree to \$1500 for 27 misclassified employees for the first offense. The total amount of \$40,500 shall be paid by certified checks by JS Interior Construction. 27 certified checks in the amount of \$750 will be made out to each misclassified employee as scheduled on the list below. An Administrative Fee of \$20,250.00 divided in 4 payments of \$5062.50 due on the first of each month beginning June 1st, 2018 with a final payments due September 1st, 2018.
- 3. In the event JS Interiors Construction Inc should default on any payments, the total remaining balance will become due immediately.

- 4. **JS interior Construction Inc** and its designees waive all rights to appeal the provisions and violations contained in this settlement agreement.
- 5. This agreement constitutes a final administrative decision under the Administrative Procedures Act and is enforceable in the Superior Court of the State of Rhode Island against the company, its successors and assignees and officer; officer and/or officer waive all rights to appeal the provisions and violations contained in this settlement agreement.
- 6. Company shall tender to the Department all payments required herein within (7) days of the due date.
- 7. This settlement agreement is a voluntary agreement and both parties fully understand and acknowledge its contents.
